The C-PACE program administrator maintains a list of service providers that have registered to participate in the program. Each registered contractor agrees to the following:

Each registered contractor shall (a) provide true, accurate, current and complete information as prompted by the registration form when registering; and (b) update and maintain the truthfulness, accuracy and completeness of such information. Registered contractors are not verified, vetted, endorsed or ranked. The program administrator reserves the right to remove a registered contractor from the database for any reason or no reason.

The registered contractor shall be and remain licensed, authorized to conduct business, and in good standing in all jurisdictions in which it conducts business, including the State of Utah, and shall have the legal authority and power to offer, sell and/or install improvements that are permanently affixed to real property (improvements). Each registered contractor shall comply with all applicable municipal, state and federal laws and regulations in the sale, provision, installation and financing of Improvements and professional services. The program administrator makes no assurances that any person or entity will gain additional business or any other business advantage from being a registered contractor and assumes no liability. Each registered contractor waives the right to bring or assert any claim against the program administrator and its vendors relating to its registration and status as registered contractor (including listing of information), and releases the program administrator and its vendors from any and all liability therefore or relating thereto.

By submission of this Registration Form, each registered contractor agrees that information provided on this form may be published or otherwise publically disseminated. Although the program administrator does not claim ownership of any of the information, by providing Information for the Registered Contractor database, each registered contractor automatically grants, and each registered contractor represents and warrants, that registered contractors have the right to grant to the program administrator an irrevocable, perpetual, non-exclusive, fully paid, worldwide license to use, copy, perform, display, reproduce, adapt, modify and distribute such information and to prepare derivative works of, or incorporate into other works, such information, and to grant and to authorize sublicenses (through multiple tiers) of the foregoing. By providing the program administrator with information, each registered contractor automatically grants the program administrator all rights necessary to prohibit the subsequent aggregation, display, copying, duplication, reproduction or exploitation of the information published or otherwise made available by the program administrator by any other party.
